The meeting was called to order at 10 a.m. by President Marv Trimble.

A motion was made by 4<sup>th</sup> VP Jason Barrick to approve the last board of directors minutes. Second from 5<sup>th</sup> VP Chuck Raska. Motion carried.

## **Executive director report:**

I would like to thank Humboldt Fire Department for hosting. We had planned to come last January and the weather didn't cooperate at all. I was getting worried earlier in the week that would happen again. The dues new renewals were mailed out middle of November and coming in steadily, keeping the office busy. Amber came January 2 to start training. So far we have gone over dues and I think she will do a great job. She came Friday to help get things ready for this meeting and go over the budget. Hopefully things will get transitioned to her very soon. We have been held up waiting on her computer and we are hoping that comes in soon so we can get everything set up there. I would like thank the membership and the board that I have worked with over the years, it has been very rewarding but it's time after 13 ½ years to focus on my kiddos. I am going to miss everybody but I am also glad to go." Wendy will stay on until March until after mid-year.

## **Financial Report:**

Total current assets for the Iowa Firefighters Association are 497,150.31 Total current assets for the Iowa Firemen's Foundation are 65,796.73 with 20.55 left over from the smoke detector account.

A motion was made by 1<sup>st</sup> VP Jim Shutts to approve the financial report. Second from 5<sup>th</sup> VP Chuck Raska. Motion carried

We are currently around 14,100 members which would give us an estimated income of \$188,500 from dues. Interest on savings accounts will be dependent on where the accounts end up when they get switched to the new bank. We added a line item in for custodian, Rick Schmitt helps every year. He had been receiving \$50 under drill expenses and will now receive \$100. Only other change was the office expense from change in salary from Wendy to Amber. We have a projected loss of \$12,175.75 A motion was made by 3<sup>rd</sup> VP Nick Riley to approve the budget. Second came from 4<sup>th</sup> VP Jason Barrick. Motion carried.

# Officers Reports:

#### 1st VP Jim Shutts:

In November I attended the Elks meeting in Des Moines. They have one question, Is there any training simulators that they could buy. I presented 2 years of service awards; one was for 54 years in Ainsworth and another for 36 years in Belle Plaine. I attended the Governor's address of the State. We are hoping that we can stay level funded through the training buearue.

The booklet that Minnesota has would be nice to look at for recruiting. I traveled to Lake City to present 2 awards, 1 was for 25 years of service and 1 was for 20 years of service. I am looking forward to Firefighter day on the Hill. Thank you Wendy for all of your time. Your service to this association has been great. Welcome Amber.

## **President Mary Trimble:**

I had the privilege of presenting a years of service award to Bill Smith at his retirement party. I've know Bill for many years. I painted a firetruck for him in the 80s. He is the one who made me think of the fire service for a profession. Bill was a career Marion firefighter. He gave 42 years of service to the citizens of Walker as a volunteer.

In December I got in the car for another presentation and drove 10 minutes to Vinton. I gave a certificate to Mike Barron for 33 years of service. Mike is my accountant. Chief Gary McKinnon was stepping down as chief after 12 years. Thank you Mike and Gary for your service to the citizens of Vinton.

January 9<sup>th</sup> I was one of six IFA board members to attend the Condition of the State address by Governor Reynolds. She talked about many topics including the budget, water quality, sexual harassment, education, healthcare, mental health, and tax reform. The budget is our greatest concern. We aren't asking for anything that requires funding. We are working to maintain level funding for the training bureau.

John Pederson is going to deliver the legislative report, so I'm not going to steel his thunder.

### **Committee Reports:**

NVFC - Bob Platz:

We would like to get the grant money back in for safer the budget. The grants total 800 million 745 afg and 755 for safer. 18 million for USFA. We tried to get the sunset out of the bill but ended up with it in 2023.

The NVFC has a cancer committee. They had a webinar in January that I attended. They plan on two more one in March and one in April. They are going to have ten commandments dealing with cancer. We are seeing a lot more cancer around the country because of all the carcinogens in a fire.

The NVFC is looking for 500 new members in Iowa by the First of May we have about 150 now. Will try to set up a booth at Midyear.

#### Legislation – John Pederson:

We contacted University of Iowa who is the National Cancer registry for the state of Iowa, they collect data. They are very interested and want to do this for firefighters. What they have done is location cancer and identifying environmental causes. They have never done one on occupational causes. We have developed a spreadsheet to send out and hope that the chief can fill out. The more we add to it the more information they will have. This will cost nothing to us.

January 18 is Firefighter day on the hill. It will start with breakfast in room 116. This is the time to pull your legislators down. Please contact your legislators when you get home, they like that personal invite. At noon we will have the chili cookoff. We cannot open it up because of outlet issues in the Capitol. John and I are constructing a funny little trophy for it. Des Moines Fire is bring some stuff that will give a good presence for us on the 1<sup>st</sup> floor. The more your legislators hear of a topic the better chance they will listen.

Thank you to those who came to the Governor's address. For those that weren't there, they are taking a hit of 20 million dollars in the current budget by July 1<sup>st</sup>. Next year it will be a 100 million dollar cut through all departments. It is very important that we start making our contacts. We are trying to keep training dollars and looking at a retirement plan for firefighters.

We are worried about DPS because of the budget and getting positions filled that need filled. Reach out to your legislators about how important training is.

We do have a meeting with DOT about the drivers license renewal.

Pro Chiefs want to meet Wednesday night before Firefighter Day on the Hill.

#### **Unfinished business:**

The office transition is going well. There is a lot to get through. The biggest hassle has been the computer and getting it delivered. Once that happens we can start getting stuff transferred. Wendy will still be available for advice once the office is transitioned to Sigourney.
